**AMENDMENT TO THE CFE ORDER**

**Order No. 265 /APPCB/CFE/RO-GNT/HO/2008      30/08/2018**

**Sub:   APPCB - CFE - M/s. Bhavya Cements Limited, Sy. No. 1172, 838-82, Tangeda (V), Dachepalli (M), Guntur District - Usage of Pet Coke as an alternative fuel in the Kiln of Cement Plant - CFE amendment order issued - Reg.**

In the reference 1st & 3rd cited, the Board issued CFE & CFO to **M/s. Bhavya Cements Limited, Sy. No. 1172, 838-82, Tangeda (V), Dachepalli (M), Guntur District** with certain conditions mentioned therein.

The EFS & T Department, Govt. of Andhra Pradesh vide reference 2<sup>nd</sup> cited issued orders declaring the Pet Coke as approved fuel.

In the reference 4<sup>th</sup> cited the industry has applied for CFE to use Pet Coke as alternate fuel in the Cement kiln. The EE, RO: Guntur submitted report in this regard vide reference 5<sup>th</sup> cited. The issue was placed before the CFE Committee in its meeting held on 21.08.2018.

The Committee after detailed discussions recommended to issue amendment to the CFE order for usage of Pet Coke as alternate fuel in the Cement kiln.

In view of the above, the Board after careful examination of the application of the industry, report of the Regional Officer and recommendation of the CFE Committee, **hereby issues amendment to CFE** to the unit under Section 25 of Water (Prevention & Control of Pollution) Act 1974 and Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and the rules made there under as following:

- a. The industry is permitted to use Pet Coke of quantity 5000 TPM (or) 166.70 TPD as alternate fuel in the Cement Kiln during the production of Clinker, in the following proportions:

Case -01	50% of Coal	50 % pet coke
Case -02	100 % pet coke	

- b. The industry is permitted to utilize Pet coke in Cement kiln only. This is subject to the orders of any Court of law.
- c. The industry shall install required air pollution control systems so that the concentration of the pollutants in the emissions shall not exceed the standards prescribed by the MoEF&CC, GoI, New Delhi from time to time.
- d. The industry shall obtain CFO of the Board.
- e. All other conditions stipulated in the CFE order issued vide reference 1<sup>st</sup> cited remain the same.
