The Board vide reference 1<sup>st</sup> cited issued CFO&HWA to M/s. Bhavya Cements Limited, Guntur District with validity upto 31.08.2018 to manufacture the following products:

S. No	Product	Quantity
1.	Cement	1.4 Million TPA
2.	Lime Stone Mining	14,85,000 TPA

The Board vide reference 2<sup>nd</sup> cited extended the validity of consent order dated 29.12.2014 for further period upto 31.08.2023.

The Board vide reference 3<sup>rd</sup> cited issued CFE amendment for usage of Pet Coke [166.70 TPD (or) 5000 TPM] as an alternative fuel in the Cement Kiln during the production of clinker.

The industry vide reference 4<sup>th</sup> cited applied for CFO for usage of petcoke as an alternative fuel in the kiln of cement plant. The EE, RO: Guntur submitted the inspection report vide reference 4<sup>th</sup> cited.

The issue was placed in the CFO Committee meeting of the Board held on 04.10.2018. After detailed discussions, the Committee recommended to issue CFO with validity upto 31.08.2023 for usage of Pet Coke - 166.70 TPD (or) 5,000 TPM as an alternate fuel in the Kiln of Cement Plant.

The Board after careful examination on RO report, agenda and recommendation of CFO committee, hereby permits the industry to use Pet Coke of 166.70 Tons/day (or) 5000 Tons/month as feed stock or in the manufacturing process in the Cement Kiln in the following proportions:

Case - 01	50% of Coal	50 % pet coke
Case - 02	100 % pet coke	

The consent order is valid upto **31<sup>st</sup> August, 2023.**

All other conditions stipulated in Schedules – A, B & C mentioned in CFO&HWA order dated 29.12.2014 will remain same.
